This AGREEMENT is made and entered into this day 8th August, 2018.

The Mizoram Youth Commission, represented for and on his behalf by its Secretary, Mizoram Youth Commission (herein after referred to as "MYC" which expression shall unless repugnant to the content or meaning thereof include its successor and permitted assigned) of the ONE PART

And

The Government J.Buana College, Lunglei represented for and on its behalf by its Principal, Prof. J.Zorema (herein after referred to as "G.J.B.C" which expression shall unless repugnant to the content or meaning thereof, include its successors and permitted assigned) of the OTHER PART.

Whereas, the MYC is entrusted to assist, guide and mould educated young persons from the state of Mizoram to acquire skill which will enable them to find gainful employment.

Whereas, the Government J.Buana College will facilitate and guide the youth of Mizoram by providing satellite online coaching class rooms in its premises.

NOW THIS AGREEMENT WITNESSES AND it is hereby agreed by and between the parties hereto as follows:

1.0 ADMISSION PROCEDURES

- 1.1** (a)MYC shall invite & shortlist applicants by advertising in local Newspapers, Local channel in Mizoram, Social media like Facebook, Whatsapp, instagram etc. And may conduct entrance test, scholarship examination if and when the need arises.
- 1.2** Registration for the course applied for shall be completed at least one week before the course commences.

1.3 Academic program – Courses of Study

The study material for the above courses shall be provided by MYC in collaboration with ALS Satellite Pvt. Ltd., New Delhi through V-SAT online.

2.0 ROLES & RESPONSIBILITIES OF G.J.B.C

- 2.1 G.J.B.C shall provide a class room spacious enough to accommodate 50 + students / Civil Service aspirants hailing from Southern region of Mizoram.
- 2.2 G.J.B.C shall provide a power backup system to support the class room. Fuels of the machine (If needed) shall be provided by MYC. The MYC students shall have an absolute right to enjoy the facilities during the class period.
- 2.3 G.J.B.C faculty members and college student in any case or under any circumstances shall respect the ongoing coaching class and shall not disturb the class and its premises.
- 2.4 In and under any specific cases, if the college authority may need/require to utilize the coaching class room, one week prior information may be furnish to the in charge officer of the MYC office, Lunglei.

3.0 ROLE & RESPONSIBILITIES OF MYC

- 3.1 MYC shall provide renovation of the infrastructure of the class room, Projector, Projector screen, Computer etc required for taking up the class.
- 3.2 The course fee for IAS online Coaching fee shall be borne by MYC.
- 3.3 The MYC shall advertise and invite eligible candidates for the course based on the format jointly agreed to the institute.
- 3.4 The MYC shall monitor the quality of the programs through officer/ staff duly authorized for the purpose.

3.5 To provide technical assistant and maintenance of class room infrastructure, one technician being designated as centre co-ordinator and one multitask worker shall be posted at the class room. Their remunerations shall be borne by ALS through MYC. The wages to be duly fixed by MYC.

3.6 The electric bill for running the online class shall be borne by MYC

4.0. JOINT RESPONSIBILITIES

4.1 Any expression or modification relating to the academic programmes etc shall be decided jointly by both the parties.

4.0 MISCELLANEOUS

5.1 The batch shall start from a mutually agreed date and may comprise of 50+ students per batch.


5.2 The agreement shall be valid for a period of two (2) years from this date and can be renewed for further period on mutual consent.
