



MEMORANDUM OF UNDERSTANDING



This Memorandum of Understanding (hereinafter referred to as 'MOU') is signed on this day,
3rd November 2023

Between

Government J. Buana College, Lunglei

(Hereinafter referred to as "the College", which expression shall include its successors and permitted assignees) on FIRST PART

And

Mizoram State Cooperative Marketing and Consumers' Federation Limited, Lunglei

(Hereafter referred to as "MIZOFED", which expression shall include its successor and permitted assignees) on SECOND PART.

Both parties, collectively referred to as "the Parties," recognise the importance of promoting practical learning and professional development among students through internship opportunities.

A. SCOPE OF COLLABORATION:

- (i) **Internship Programme:** MIZOFED agrees to offer internship opportunities to students of the College. The internship programme shall provide students with hands-on experience and exposure to various aspects of the organisation's undertakings.
- (ii) **Internship Duration:** The internship duration shall be determined by mutual agreement between the College and MIZOFED.

- (iii) **Internship Positions:** MIZOFED shall determine the number of internship positions available, the departments or branches where interns will be placed, and the specific roles and responsibilities of interns. The College will provide eligible students who meet MIZOFED's requirements.
- (iv) **Selection Process:** MIZOFED and the College will jointly establish a fair and transparent selection process for interns. MIZOFED reserves the right to interview and select candidates based on its criteria.
- (v) **Training and Supervision:** MIZOFED shall ensure that interns receive adequate training and supervision during their internship. The College may provide guidance on academic aspects of the internship programme.

B. RESPONSIBILITIES:

The Parties agree to the following responsibilities:

- (i) **Government J. Buana College:**
 - (a) Facilitate the identification of eligible students for internship opportunities.
 - (b) Provide necessary information about the academic requirements for the internship programme.
 - (c) Assist in coordinating the selection and placement of interns at MIZOFED.
- (ii) **MIZOFED:**
 - (a) Offer internship opportunities to eligible students of the College.
 - (b) Provide adequate training and supervision for interns during their internship period.
 - (c) Evaluate intern performance and provide feedback as required.
 - (d) Comply with all relevant laws and regulations governing internships.

C. CONFIDENTIALITY:

The Parties agree to maintain the confidentiality of any proprietary, sensitive, or confidential information that may be shared during the course of the internship programme.

D. TERMINATION:

Either Party may terminate this MOU with written notice to the other Party, providing a reasonable explanation for termination. Termination will not affect the obligations related to ongoing internships.

E. AMENDMENTS:


Any amendments to this MOU must be made in writing and mutually agreed upon by both Parties.

This MOU shall commence on the date of signing and shall remain in effect until terminated by either Party.


